02. If the candidate found guilty or impersonation or submitting fabricated or tempered documents/testimonials or making statement which are incorrect/false or suppressing material information shall render such person liable for legal action under law and his candidature shall be cancelled. In case such a defaulter is traced after selection, his contract shall be terminated.
03. The candidate shall have to submit an affidavit duly attested by the Judicial Magistrate to the effect that:-
