
GMC Anantnag was established in 2019 by the Ministry of Health & Family Welfare, Government of India under a Centrally Sponsored Scheme. Apart from the duty to provide a high-quality community and patient-focused health care that is readily accessible, this college provides teaching and scientific research opportunities.

The Institutional Ethics Committee, Government Medical College, Anantnag (IEC-GMCA) plays an important role in guiding researchers in the ethical aspects associated with the research. IEC-GMCA is working continuously to uphold the standards of research in the college. Apart from ethical issues, IEC-GMCA also reviews the research proposals for the scientific relevance and risk involved in research. IEC-GMCA functions as per the ICMR National Ethical Guidelines for Biomedical and Health Research involving Human Participant-2017, ICH-GCP and New Drugs and Clinical Trials Rules 2019.


IEC-GMCA has been registered with Central Drugs Standard Control Organization (CDSCO) since November 2023 and on 18 April 2024 the Department of Health Research (DHR) accredited registration to the committee in the National Ethics Committee Registry for Biomedical and Health Research (NECRBHR). The registration of the committee by both the apex agencies puts IEC-GMCA in a unique position to carry out both biomedical/ health research and clinical trials. IEC-GMCA is perhaps the first among new medical colleges of J & K to have a dual registration.
