**TERMS AND CONDITIONS**

- 1) In case the engaged candidate fails to join within a period of (14) days from the date of publication of this engagement order, it will be presumed that she is not interested to join the department and for that reason waiting list shall be operated.
- 2) If the candidate found guilty or Impersonation or submitting fabricated or tempered documents/ testimonials or making statement which are incorrect/false or suppressing material information shall render such

person liable for legal action under law and her candidature shall be cancelled. In case such a defaulter is traced after engagement, her contract shall be terminated.

- 3) The candidate shall have to submit an affidavit duly attested by the Judicial/ Ist Class Magistrate to the effect that:-
- I shall not claim for any regular appointment in the department.
  - I will not participate in any kind of strike during my tenure.
  - I shall remain disciplined during my tenure of service in the institute.
  - I am not involved in any criminal/subjudice activity nor there is any FIR pending/registered in Police Department against me.
- 4) The engagement is purely temporary basis for a period of one year on contractual basis or till the post is filled on regular basis, whichever is earlier. However, in case of unsatisfactory performance, the contractual engagement can be terminated.
