Subject: Engagement of Senior Resident/Tutor/Demonstrator on Academic Arrangement Basis under S.O-364 in the Department of Radio-Diagnosis, Govt. Medical College Anantnag.

Whereas, Govt. Medical College Anantnag advertised vacant posts of Senior Residents/Tutor/Demonstrator in various departments vide Advertisement Notice No. 06 GMCA of 2024 dated 16.10.2024;

Whereas, the written test for the said post in the discipline of Radio-Diagnosis was conducted on **02.12.2024** at Main Campus Dialgam, GMC Anantnag;

Whereas, the provisional merit list of the written test for the said post was published on college website vide Notice No. GMCA/PD/RA/2024/1420-23 dated 09.12.2024;

Therefore, in view of the above, **Dr Sheikh Burgees Ismail D/O Dr Sheikh Mohd Ismail R/O Heaven Colony Ashajipora, Anantnag** figuring at S. No. 01 in the merit list is hereby engaged as Senior Resident/Tutor/Demonstrator in the Department of Radio-Diagnosis Govt. Medical College, Anantnag on Academic Arrangement basis under S.O-364 of 2020 dated 27-11-2020 for a period of one (01) year.

The engagement of doctor is subject to the following terms and conditions:

1. Before joining the Department, the selected candidate shall submit an affidavit in the office of the Registrar Academics, Govt. Medical College Anantnag duly attested by the Judicial Magistrate to the effect that:
 - a. If the information furnished by him/her in the application form is found wrong at any point of time, he/she shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
 - b. He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - c. He/she shall remain disciplined during the tenure period, any kind of misconduct shall make him/her liable for termination without any prior notice.

- d. He/she is not involved in any criminal activity nor is there any FIR/Court case pending/registered against him/her in any criminal department or police station/Hon'ble Court.
 - e. His/her engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification. In case adverse report is received from CID, J&K, he/she shall not claim for engagement which shall be deemed to have been cancelled ab-initio.
 - f. He/she shall not claim any Experience Certificate in case he/she leaves Senior Residency before completion of first six months.
 - g. The selected candidate shall have to execute an agreement as mentioned in S.O 364 of 2020 dated 27.11.2020 and that he/she will not leave the Department before the completion of tenure (six months), however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side falling which the salary shall not be paid for one month to the incumbent and shall be released on completion of sanctioned term.
 - h. He/she will not indulge in any private practice. In case he/she is found doing private practice his/her appointment shall be liable for termination without any notice.
 - i. **That I was appointed in GMC Srinagar as registrar vide Notification No. RA-GMCS/R/D/Adv/2553-58/MC dated 03.10.2022 and I have submitted my resignation in the said institution.**
2. The above doctor shall have to execute an agreement with the Institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
 3. PSC confirmed appointees are required to furnish the NOC from Director Health Services concerned before their joining, failing which they will not be allowed to join.
 4. The appointee(s) is/are required to join in the office of Registrar Academics, GMC Anantnag within **14 days** from the date of issuance of this order failing which the order shall be deemed to have cancelled.
 5. The Senior Resident appointed on Academic Arrangement basis shall be paid as per S.O 364 of 2020 dated 27-11-2020.
 6. The salary of the appointed candidate shall be drawn/dispensed only after recipient of verification of character & antecedents and documents/ testimonials from the concerned quarters.
 7. **The selected candidate shall be relieved from her tenure post (Registrar) at GMC Srinagar prior to joining at GMC Anantnag ensuring that her total tenure for the said post across these institutions does not exceed three (03) years.**


