Subject: Cancellation of Selection and Operation of Waiting list thereof for the post of "Junior Staff Nurse" on Academic Arrangement Basis, under SO-364 in Government Medical College Anantnag.

Reference: Order No.282 GMCA of 2021 dated 08.10.2021

Whereas, subsequent to the recommendation by the designated Selection Committee constituted for engagement of Junior Staff Nurse on Academic Arrangement under SO-364, (09) candidates were selected against the post of Junior Staff Nurse vide this office order No.282 GMCA of 2021 dated 08.11.2021.

Whereas only (06) candidates have reported in GMC Anantnag within stipulated time for document verification / joining and (03) candidates mentioned at Annexure "A" failed to report for document verification/ joining within the stipulated time.

Therefore selection in favour of candidates listed in Annexure "A" who failed to report for document verification and also submitted undertaking to the effect of non-intension of their joining in GMC Anantnag, is hereby cancelled ab-initio.


In view of the above, the candidates figuring in waiting list listed at Annexure "B" are selected against available vacant posts of "Junior Staff Nurse" **on Academic Arrangement under SO-364** in GMC Anantnag on contractual basis for a period of one year only in GMC Anantnag.

Candidates shall report to the Principal Government Medical College, Anantnag for document verification/joining within a period of 21 days from the date of issuance of this order, failing which their selection shall stand cancelled ab-initio without any further notice and candidates next in waiting list shall be considered for selection.


The appointment of these candidates shall be subject to the following conditions:

She/He shall have to submit an affidavit duly signed by 1st Class Magistrate to the effect that:

1. I will adhere to the roster of duties to be issued by the administration.
2. I will not participate in any kind of strike/protest against the administration during my tenure in the college/hospital.
3. My engagement shall be purely on contractual basis and shall be non-transferable.
4. My engagement is contractual and do not confer any right for the permanent absorption in the department.
5. My engagement shall be terminated on account of non/poor performance/adverse conduct without any notice,
6. If the documents filed by me are found wrong/incorrect at any point at time, my selection shall be terminated immediately and disciplinary action and legal proceedings shall be initiated against me alongwith recovery of remuneration.
7. I will reside in the vicinity of GMC Anantnag during the whole period of my temporary services as Junior Staff Nurse under SO-364 in GMC Anantnag and shall provide residential details in GMC Vicinity to the administration at the time of joining.
