NOTICE FOR SCREENING (WRITTEN TEST)

It is hereby notified for information of all the eligible candidates who have applied online and submitted hard copies in the office of undersigned for the posts of **FMPHW** and **Staff Nurse** under National Health Mission (NHM) vide advertisement Notification Nos. **18 GMCA of 2022 dated 29.10.2022** and **19 GMCA of 2022 dated 29.10.2022** respectively in Govt. Medical College Anantnag, that the screening (Written test) is scheduled to be held on **13.11.2022 (Sunday)** starting from **11.00 AM to 12.00 PM** for the post of Staff Nurse and from **02.00 PM to 03.00 PM** for the post of FMPHW at **Government Degree College (Women's), K.P Road Anantnag.**

1. The list of eligible candidates is provisional and has been devised on the basis of information provided by the candidates in application forms.
2. The candidates are informed to download the acknowledgement slips (Admit Cards) available on College Website (www.gmc.anantnag.net) from 10.11.2022 at 11.00 AM onwards. Any candidate who faces any kind of problem in downloading admit card may approach the office of Administrative Officer, Government Medical College, Anantnag at Main Campus, Dailgam on 12.11.2022 (Saturday) after 2 PM.
3. The candidates are mandated to report examination centre **one hour** before the scheduled time along with **acknowledgement slips, Identity Proof (Original)** and **two passport size photographs**. No such candidate shall be allowed to appear in the examination who doesn't possess the above requisite documents.
4. No candidate shall be allowed to appear in both the examinations, if any such candidate found present in both the shifts, his/ her candidature shall be cancelled ab-initio for both the posts.
5. No electronic gadgets (Calculators, mobile phones, smart watches, Bluetooth devices etc) shall be allowed in the examination centre. If any such device found within the examination centre, his/ her candidature will be cancelled and legal action under rules will be initiated against him/ her.
