Whereas, Government Medical College Anantnag advertised vacant posts of Senior Resident/Tutor/Demonstrator in various departments vide advertisement Notice No. 07 GMCA (RA) of 2024 dated 06-12-2024 on academic arrangement basis under S.O 364 of 2020 dated 27.11.2020;

Whereas, the written test for the post of Senior Resident/Tutor/Demonstrator in the discipline of Pathology was conducted on **29.01.2025** at Main Campus Dialgam, Government Medical College Anantnag;

Whereas, the provisional merit list of the candidates who have appeared in the said written test was published vide notification No. GMCA/Estt/2025/809-12 dated 04.02.2025;

Therefore, in view of above, below mentioned candidate is hereby engaged as Senior Resident/Tutor/Demonstrator in the Department of Pathology, Government Medical College Anantnag on Academic Arrangement Basis under S.O 364 of 2020 dated 27.11.2020 initially for a period of one year which is extendable upto (03) years on the basis of good performance to be certified by the concerned Head of Department.

The engagement of doctors is subject to the following terms and conditions:

- Before joining the Department, the selected candidate shall submit an affidavit in the office of the Registrar Academics, Govt. Medical College Anantnag duly attested by the Judicial Magistrate to the effect that:
 - If the information furnished by him/her in the application form is found wrong at any point of time, he/she shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
 - He/she have not completed the tenure in the same college or any other college strictly as per advertisement notice.
 - He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - He/she shall remain disciplined during the tenure period, any kind of misconduct shall make him/her liable for termination without any prior notice.
 - He/she is not involved in any criminal activity nor is there any FIR/Court case pending/registered against him/her in any criminal department or police station/Hon'ble Court nor there is any criminal/civil case subjudice in any court of law against me.
 - His/her engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification. In case adverse report is received



from CID, J&K, he/she shall not claim for engagement which shall be deemed to have been cancelled ab-initio.

- g.** He/she shall not claim any Experience Certificate in case he/she leaves Senior Resident-ship before completion of first six months.
 - h.** The selected candidate shall have to execute an agreement as mentioned in S.O 364 of 2020 dated 27.11.2020 and that he/she will not leave the Department before the completion of tenure (six months), however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side falling which the salary shall not be paid for one month to the incumbent and shall be released on completion of sanctioned term.
 - i.** He/she will not indulge in any private practice. In case he/she is found doing private practice his/her appointment shall be liable for termination without any notice.
2. The above doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
 3. In-service (PSC confirmed) candidates shall be paid salary as per their LPC. The PSC confirmed appointees are required to furnish the NOC from Director Health Services concerned before their joining, failing which they will not be allowed to join.
 4. The appointee(s) is/are required to join in the office of Registrar Academics, GMC Anantnag within **14 days** from the date of issuance of this order falling which the order shall be deemed to have cancelled.
 5. The Senior Resident appointed on Academic Arrangement basis shall be paid as per S.O 364 of 2020 dated 27-11-2020.
 6. The salary of the appointed candidate shall be drawn/dispursed only after recipient of verification of character & antecedents and documents/ testimonials from the concerned quarters.

Note: The engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification.
