

- case such a defaulter is traced after selection, his/her contract shall be terminated.
3. The candidate(s) shall have to submit an affidavit duly attested by the Judicial/1st Class Magistrate to the effect that: -
 - a. That incase any adverse report about Qualification, Date of Birth, Marks Certificates, Reserved Category certificate, Domicile Certificate etc, if any, is received from the concerned authority, the candidates(s) shall have no right to claim his/her engagement for the post selected as such my selection shall be deemed to have been cancelled ab-initio. I will not also claim any dues from GMC Anantnag as well in that case.
 - b. I will not participate in any kind of strike during my tenure.
 - c. I shall remain disciplined during my tenure of service in the institute.
 - d. I am not involved in any criminal/subversive activity nor there is any FIR pending/registered in the Police Department against me or any case subjudice in any court of law.
