Whereas, the following candidates figuring at S.No.06 and S.No 09 in selection list were selected against the post of "**Junior Staff Nurse**" on Academic Arrangement in GMC Anantnag under SO-364 dated 27.11.2020.

Whereas, verification of character and antecedents of the above candidates has been reported satisfactory by CID, J&K, vide reference cited above.

In view of the above, the above mentioned candidates are engaged against the vacant posts of **Junior Staff Nurse** on Academic Arrangement Basis under SO-364 dated 27.11.2020 in Govt. Medical College Anantnag for a period of one year or till the posts are filled up on regular basis, whichever is earlier.


The engagees are directed to join in Government Medical College Anantnag within a period of 21 days from the date of issuance of engagement order.

The engagement order of the candidate shall be subject to the following conditions:

1. The candidate, if fails to join within a period of 21 (Twenty one) days from the date of issuance of the engagement order shall forego his/her right to engagement which shall be deemed to have been cancelled ab-initio without any further notice.
2. Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities and recognition of Institutions issuing degree/diploma.
3. The honorarium of the engagee shall be drawn and disbursed only after receipt of genuineness of the qualification certificates from the concerned issuing authorities.

The candidate shall give an undertaking in the shape of an Affidavit duly signed by 1<sup>st</sup> class Magistrate to the effect that:

- a) If the information furnished by me in the application form is found wrong at any point of time, I shall be liable for punishment under rules.
- b) I will not participate in any kind of strike/protest during my tenure.
- c) I shall not claim for permanent absorption in the department. Besides my tenure shall be terminated once the recruitment of posts of Junior Staff Nurse is done by JKSSB on regular basis and I shall not claim for extension at the time.
- d) I shall remain disciplined during my tenure in the college.
- e) I will reside in the vicinity of GMC Anantnag.
