Subject:- Cancellation of Appointment and Operation of waiting list thereof for the post of Radiographic Technician (Health & Medical Education Department) in GMC Anantnag.

Whereas Pursuant to the recommendations of Jammu & Kashmir Service Selection Recruitment Board vide communication No. SSB/Secy/Sel/25(k)/2020/2375-81, dated. 16-03-2020. **(02)** candidates were selected against the post of of **Radiography Technician** under RBA category in GMC Anantnag.

Whereas, selection list of one candidate Mr.Ishfaq Ahmad Lone figuring at S.No.01 under RBA Category has been cancelled by JKSSB vide order No. 234-SSB of 2022, dated.18-07-2022

Whereas another candidate Mr.Hilal Ahmad Lone figuring at S.No.2 under RBA category was appointed in GMC Anantnag vide order No. 131 of GMCA of 2022, dated.18-07-2022. However, the said candidate failed to join within the stipulated time of 21 days. Therefore, appointment in favour of Mr. Hilal Ahmad lone S/O Ghulam Mohammad lone R/O Tangmarg, warapora, Baramulla is hereby cancelled ab-initio.

Whereas, Mr. Shabeer Hassan S/O. Gh Hassan Bhat figuring in waiting list under under RBA Category at S.No.2 whose recommendation was kept withheld, which has now been released by the JKSSB vide their communication No. JKSSB-SD0SECY(KAS)/15/2022-03, dated. 09-03-2023, duly forwarded by Health & Medical Education Department vide their letter No. ME-NG/343/2021-02, dated. 17.04.2023,

In view of the above, Sanction is hereby accorded to the temporary appointment of Mr. **Shabeer Hassan S/O Gh Hassan Bhat R/O Dialgam, Anantnag** against the post of **Radiography Technician** (Health & Medical Education Department) under RBA category in the pay level 4 (25500-81100) in Govt.Medical College Anantnag.

The appointment of candidate(s) shall be subject to the production of the following documents in original:-

- Date of Birth Certificate.
- Academic/Technical Qualification Certificates.
- Domicile Certificate.

- iv. Medical Fitness Certificate from CMO, concerned.
- v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Relevant category certificate(s), (in case of candidates belonged to reserved categories).
- vii. Any other document(s) as required under rules.

The appointment of the above candidate(s) shall be subject to the fulfillment of following conditions:-

1. The appointees shall join within a period of 21 (twenty one) days from the date of issuance of the appointment order. In case the appointees fails to join within a period of 21 (twenty one) days from the date of issuance of appointment order, he/she shall forego his/her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
2. Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
3. The salary of the appointees shall not be drawn and disbursed to him/her unless, satisfactory report in respect of the (2) above is received in his/her favour.
4. The appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 17.06.2020.
5. The interim arrangement, if any, made against the above post shall be deemed to have been terminated forthwith.
6. The appointment in Divisional cadre is non-transferable from one division to another or from one Medical College to another.
7. The seniority of the above appointee(s) shall be as per the merit secured by him/her in the select list furnished by the J&K Services Selection Board.
8. The appointment of the above candidate(s) shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
9. The candidate shall have to submit an affidavit duly attested by the Judicial/Ist Class Magistrate to the effect that:-
 - i. If I found guilty of submitting fabricated or tempered documents/testimonials or making statement which are incorrect/false or suppressing material information shall render me liable for legal action under law and my appointment shall be terminated.
 - ii. I will not participate in any kind of strike during my tenure in the college/Hospital under any circumstances.
 - iii. I shall remain disciplined during my tenure of service in the institute.
 - iv. I am not involved in any criminal/subjudice activity nor there is any FIR pending/registered in Police Department against me.
 - v. I will reside in the vicinity of the GMC Anantnag.
