

1. The candidate, if fails to join within a period of 21 (Twenty one) days from the date of issuance of the engagement order shall forfeit his/her right to engagement which shall be deemed to have been cancelled ab-initio without any further notice.
2. Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities and recognition of Institutions issuing degree/diploma.
3. The honorarium of the engagee shall be drawn and disbursed only after receipt of genuineness of the qualification certificates from the concerned issuing authorities.

The candidate shall give an undertaking in the shape of an Affidavit duly signed by 1st class Magistrate to the effect that:
