3. The candidate shall have to submit an affidavit duly attested by the Judicial/ 1<sup>st</sup> Class Magistrate to the effect that:-

  - b) I will not participate in any kind of strike during my tenure.
  - c) I shall remain disciplined during my tenure of service in the institute.
  - d) I am not involved in any criminal/ sub-judice activity nor there is any FIR pending/registered in Police Department against me.
