Operation of Merit List against the post of Senior Resident on Academic Subject: Arrangement basis under S.O 364 of 2020 dated 27.11.2020 in the Department of Obstetrics & Gynecology, GMC Anantnag.

Whereas, Government Medical College Anantnag advertised vacant posts of Senior Resident in various departments vide advertisement Notice No. 05 GMCA (R&I) of 2024 dated 27-06-2024 on academic arrangement basis under S.O 364 of 2020 dated 27.11.2020;

Whereas, selection list for a post of Senior Resident in the department of Obstetrics & Gynecology, Government Medical College Anantnag was issued vide order No. 295 SR/GMCA of 2024 dated 14-08-2024;

Whereas, one post of Senior Resident become vacant due to resignation of Senior Resident on 13-11-2023 in the Department of Obstetrics & Gynecology, Government Medical College, Anantnag;

Whereas, the candidates falling next in the merit list Dr Tabeer Shoaib S/o Shoaib Ahmad Kamil & Dr Beigh Saima Farooq D/o Farooq Ahmad Beigh have shown their unwillingness to join this institute against the said vacant post, to which they have submitted an undertaking duly signed by the concerned candidates;

Therefore, in view of above, Dr. Danish Ahmad Dar S/O Abdul Hai Dar R/O Nildora Shopian falling next in merit is hereby engaged against the post of Senior Resident in the Department of Obstetrics & Gynecology, Government Medical College Anantnag on Academic Arrangement Basis under S.O 364 of 2020 dated 27.11.2020 initially for a period of one year which is extendable upto (03) years on the basis of good performance to be certified by the concerned HoD.

The engagement of the doctor is subject to the following terms and conditions:

- 1. Before joining the Department, the appointee shall submit an affidavit in the office of the Registrar Academics, Government Medical College Anantnag duly attested by the Judicial Magistrate to the effect that:
 - a. If the information furnished by him/her in the application form is found wrong at any point of time, he/she shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
 - b. He/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - c. He/she shall remain disciplined during the tenure period, any kind of misconduct shall make him/her liable for termination without any prior notice.
 - d. He/she is not involved in any criminal activity nor is there any FIR/Court case pending/registered against him/her in any criminal department or police station/Hon'ble H & Ste Per Court.

- e. His/her engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification. In case adverse report is received from CID, J&K, the engagement will be cancelled ab-initio and he/she shall not claim for salary in GMC
 - f. He/she shall not claim any Experience Certificate in case he/she leaves Senior Resident-ship before completion of first six months.
 - g. He/she will not indulge in any private practice. Incase he/she is found doing private practice his/her appointment shall be liable for termination without any notice.
- 2. The above doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
 - 3. PSC confirmed appointees are required to furnish the NOC from Director Health Services concerned before their joining, failing which they will not be allowed to join.
 - 4. The appointee(s) is/are required to join in the office of Registrar Academics, GMC Anantnag immediately from the date of issuance of this order, failing which the engagement shall be deemed to have been cancelled.
 - 5. The Senior Resident appointed on Academic Arrangement basis shall be paid as per S.O 364 of 2020 dated 27-11-2020.
 - 6. The salary of the appointed candidates shall be drawn/disbursed only after recipient of verification of character & antecedents and documents/ testimonials from the concerned quarters.
