If the candidate(s) found guilty or impersonation or submitting fabricated or tempered documents/ testimonials or making statement which are incorrect/false or suppressing material information shall render such person liable for legal action under law and his/her candidature shall be cancelled. In case such a defaulter is traced after selection, his/her contract shall be terminated.
03. The candidate(s) shall have to submit an affidavit duly attested by the Judicial/ 1st Class Magistrate to the effect that:-
 - a.
