Basic Qualification	<ol style="list-style-type: none">1. As per the advertisement, candidates must have a degree or diploma in Medical Lab Technology (MLT)2. Candidates with degrees or diplomas other than those specified are ineligible.
Experience Certificate Guidelines	<ol style="list-style-type: none">1. The experience must be in a recognized medical laboratory in a Central/UT Government Hospital or Institute2. All experience certificates from GMCs or associated hospitals must be issued by the Office of the Principal/Registrar Academics.3. For other institutes, the experience certificate must be issued by the Medical Superintendent or Highest authority of the institution, counter-signed by the CMO and accompanied by a salary slip.
