Note:

1. The candidates who have submitted the representations may be made provisionally eligible and are directed to submit the requisite documents at the time of collecting their admit cards.
2. The candidates shall submit an affidavit at the time of collecting their admit cards wherein it shall be mentioned that their eligibility will be subject to production of equivalence certificate from the Registrar of their University and the candidates shall not claim for the post if they fail to produce the same.
3. The candidates should read carefully all the instructions mentioned on the admit card.
4. Candidates are also advised to report examination center one hour before schedule time along with Admit Card, ID Proof (original) and recent Passport size photograph. No such candidate shall be allowed to appear in the examination who do not meet the above-mentioned pre-requisites.
5. Only those candidates should appear in the written examination, who fulfil the eligibility criteria prescribed for the post as mentioned in the notification.



If any such device is found with the candidate in the examination center, his/her candidature will be cancelled and legal action under rules will be initiated against him/her.
